### DIRECTIONS FOR USE

#### APPLICATION

1. EVO-STIK Grip Filth Hand Wipes have been designed for use on hands, but may also be used on tools and surfaces.
2. Always test on an inconspicuous area first. Not suitable for porous or delicate surfaces.

Non-hazardous. EVO-STIK Grip Filth Hand Wipes have been dermatologically tested and have a Safety Assessment. The wipes are designed to remove greasy stains and material from hands, so should not be used to clean food containers or utensils.
